- 5 Any deviations w.r.t. construction shall be verified by the concerned building sanctioning agency.
- 6 The certificate may not be treated in any case for the regularization of the unauthorized construction, if any.
- 7 The owner/ occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry. [www.dfs.delhigovt.nic.in](http://www.dfs.delhigovt.nic.in).
- 8 Basement shall be used strictly as per building bye laws.
